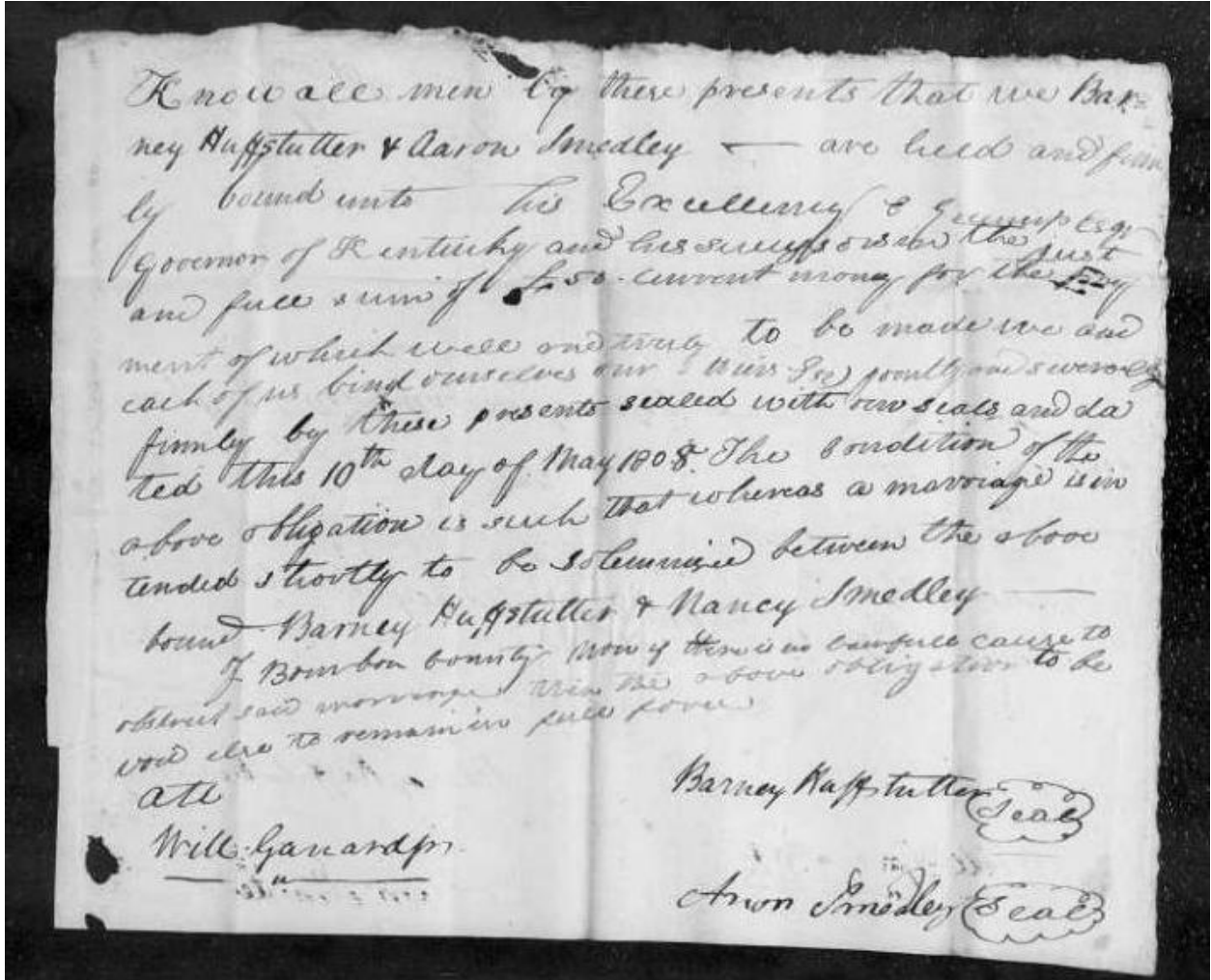


Huffstudler / Huffstutter of Central Kentucky

MARRIAGE BOND JANE HUFFSTUDLER TO MICHAEL KEITH

HARRISON COUNTY, KENTUCKY 13 OCTOBER 1821

Know all men by these presents that we Michael
Keith & Levi Keith are held
and firmly bound unto the Commonwealth
of Kentucky in the sum of £50 current mon-
ey and for payment well and truly to be
made to the said Commonwealth we
bind ourselves here Exrs of admors jointly
severally and firmly by these presents
sealed and dated this 13th day of October 1821

The condition of the above obli-
-gation is such that whereas a Marriage
is shortly intended to be solemnized betw
-us the above bound Michael Keith & Jane
Huffstudler now should there be no lawful
cause to obstruct said Marriage then
the above Obligation to be void Else to remain
-in its full force and virtue in Law
